# TERMS & CONDITIONS

## Confirmation

---

A booking will be confirmed on receipt of signed Terms and Conditions and payment of the agreed room hire deposit, which will be provided by your function manager. Management will hold a tentative booking for 48 hours if requested. If the signed Terms and Conditions and deposit have not been received within this time, The Grove Establishment reserves the right to release the date to another client.

## Final Details

---

Final Details Form (provided by event coordinator) is due no later than 13 working days prior to the booking date. At least 20% of the agreed minimum spend must be allocated towards catering. Menus are subject to change at any time in line with produce availability. Apart from birthday cakes, no other food is permitted to be brought into the venue. Final number and prepayment are due 5 working days prior to the booking date. Decreased event numbers within 5 working days will not be accepted. Increased event numbers within 5 working days must be discussed with Event Coordinator

## Payment

---

Final numbers and catering orders MUST be placed and finalized 14 days prior to the function date. Catering, beverage packages and bar tabs are to be paid in full 7 days prior to the function. Upgrades and additional funds can be added to the bar tab on the date of the event, only with the function manager or the function host.

## Cancellations

---

In the instance that a function is to be cancelled, written notification must be made to the function manager.

Any bookings made between the 1st of November and the 1st of January are subject to a strict no-refund policy, and if the function is cancelled at any time, the full deposit will be forfeited.

# TERMS & CONDITIONS

## **Catering and Beverage Options**

---

Please be aware that all produce is subject to availability. If in the instance a certain item cannot be provided by our kitchen team, your function host will notify you immediately so alternative arrangements can be made. If your function requires excess catering due to a change in numbers, you must notify the function manager as soon as possible. Decreased event numbers within 5 days prior to the function will result in a strict no refund policy on pre ordered and paid catering and beverage packages.

## **Minors**

---

Any guests under the age of 18 years must have their parent or legal guardians supervision at all times and are restricted to movements within their designated function area. Minors are not permitted to approach the bar without the accompaniment of an adult. Any member of the function wishing to drink alcohol must be able to produce valid identification (drivers license, passport or proof of age card only) and failing to do so will be refused service and will have to adhere to the expectations of a minor. All minors are permitted to remain on premise until 10PM at which point they must vacate the premise. Please note that The Grove Establishment has a zero tolerance on under age drinking and should a minor be found consuming alcohol the function will be shut down immediately, and full payment will be forfeited. Furthermore, any person who is caught providing alcohol to a minor will be escorted off premise and reported to the police.

## **Unduly intoxicated and disorderly patrons**

---

As stated in the Liquor Act 1992, it is prohibited to supply alcohol to a disorderly or unduly intoxicated person. Patrons showing signs of undue intoxication or disorderly behaviour will be refused service and asked to leave the premise. The Grove Establishment will not tolerate any verbal or physical harassment of patrons or staff and anyone in violation of these expectations will be evicted immediately. If any persons attending your function are asked to leave the premise and do not comply, your function will be immediately shut down, forfeiting any payment made. Management reserves the right to refuse service to any patron with a justifiable cause. All guests attending your private function are to be made aware that no exceptional treatment will be made in their case, and will be held to the legal expectations of all other individuals in the licensed premise.

# TERMS & CONDITIONS

## Damages and Personal Property

---

At the commencement of each function, the clients will be asked to submit a credit card with a proof of identification to the function host to be held as a deposit in case of damages. The cost of repair of any damages to venue property made during the function will be charged to the credit card and returned to the owner. All belonging and gifts are to be collected on conclusion of the function unless previously arranged with the function manager. The Grove Establishment does not accept responsibility for the damage or loss of any property left on premise prior to, during, or after a function. In the instance that alcohol is provided as a gift or prize in any function, management will store the alcohol in a designated location until the conclusion of the function, in which it will be returned to the owner.

## Decorations

---

We request that no nails, tape, pins, staples or hooks be used for attaching displays or decorations. All decoration details and expectations are to be discussed and finalized with the function manager 14 days previous to the function date.
